





- · 3.75% interest rates for businesses without credit available elsewhere
- · 2.75% interest rates for nonprofits.
- . Terms of the loan may be up to 30 years.
- . Loans can be used for payroll, fixed debts, accounts payable, or other bills.
- The SBA will work with businesses to create a plan that accounts for their ability to repay
 the loan.

Small business Administration (SIAI) provides low-interest, long-term disuster loans to businesses of all sizes, private non-profit organizations, homeowners, and renters to repair or replace unincurved/underinsurved disaster damaged property.
